Dear Tribal Representative:

In accordance with 18 CFR § 5.18, Placer County Water Agency (PCWA) filed with the Federal Energy Regulatory Commission (FERC or Commission) the Draft Application for New License (Draft License Application) for the Middle Fork American River Project (MFP or Project), FERC Project No. 2079 on September 28, 2010.

The Draft License Application is comprised of five volumes, including public, critical energy infrastructure, confidential, and privileged information. Enclosed is an outline of the material contained in each volume. Public versions of the Draft License Application are being sent to you under separate cover. Enclosed for your review is Volume 5 (one paper copy and one electronic copy). This volume is not provided to the public.

A copy of Volume 5 has also been provided to the FERC's Secretary; FERC's archaeologist, and cultural resource specialists at United States Department of Agriculture – Forest Service, Tahoe National Forest and the Eldorado National Forest. .

Comment on the Draft License Application will be accepted for 90 days, with the comment period closing on December 27, 2010. Comments should be submitted to:
