Subject: Placer County Water Agency's Response to United Auburn Indian Community of the Auburn Rancheria Comment Letter Dated July 6, 2011 on the Middle Fork American River Project (FERC Project No. 2079-069)

Dear Mr. Baker:

Placer County Water Agency (PCWA) is the existing Licensee and applicant for a subsequent license for the Middle Fork American River Project (Federal Energy Regulatory Commission (FERC) Project No. 2079) (MFP or Project). PCWA filed its Draft License Application for the MFP on September 28, 2010 and its Final License Application (FLA) on February 23, 2011. FERC issued its Notice of Application Accepted for Filing, Soliciting Motions to Intervene and Protests, Ready for Environmental Analysis, and Soliciting Comments, Recommendations, Preliminary Terms and Conditions, and Preliminary Fishway Prescriptions on June 7, 2011. In response, the United Auburn Indian Community (UAIC) of the Auburn Rancheria filed comments with FERC on July 25, 2011. PCWA has reviewed the UAIC comments and provides the following responses.

UAIC COMMENT NO. 1

The UAIC contends that the wave action, inundation, and deflation occurring along the ordinary high water mark and the fluctuation zones are adversely affecting the eligible historic properties found at those levels and that those properties will require data recovery.

PCWA RESPONSE NO. 1

Focused consultation to develop a Historic Properties Management Plan (HPMP) for the MFP has occurred since February 23, 2009, and has consisted of in-person meetings with the USDA-FS, Native American Tribes, and other members of the Cultural Resources Technical Working Group (CUL TWG); e-mail and written correspondence; and distribution of draft versions of the HPMP for review and comment. As a result of these collaborative discussions, PCWA prepared a Revised Draft Historic Properties Management Plan (HPMP) (dated May 2011). PCWA's consultation effort related to preparation of the Revised Draft HPMP is documented in Attachment A (Revised Draft HPMP Table 2) and PCWA's FLA (Tables 14-2, 14-3, and 14-6).

The Revised Draft HPMP describes the measures that PCWA will implement to manage the four properties located within the Area of Potential Effect (APE) that are eligible for the National Register of Historic Places (NRHP). The HPMP also describes how PCWA will manage Project activities that may affect Traditional Gathering Areas and paleontological resources (although to date, none have been identified in the Project vicinity). The HPMP describes monitoring of cultural resources within the APE over the term of the license. The Revised Draft HPMP includes discussion of fluctuating water surface elevations (WSE) at a Project reservoir and measures to manage an NRHP-eligible site, as detailed below.

The UAIC comment is referring to an NRHP-eligible site (FS-05-03-55-682) located below the maximum operating WSE of a Project reservoir. This site and the immediate vicinity was visited and formally recorded on July 31, 2008 as part of PCWA's relicensing studies. The site was revisited on March 10, 2009, at which time the site was evaluated for NRHP-eligibility. In August 2009, PCWA co-sponsored with the Eldorado National Forest (ENF) additional surveys, including documentation of the site (FS-05-03-55-682). A complete description of this site and a discussion of its attributes relevant to the NRHP-eligible criteria is available in PCWA's CUL 1 – Cultural Resources National Register of Historic Places Eligibility Report, provided in Supporting Document D of PCWA's Application for New License filed February 23, 2011.

This site was recommended eligible for inclusion on the NRHP based on PCWA's studies. The California State Historic Preservation Officer (SHPO) concurred with PCWA's eligibility recommendation by letter dated June 22, 2010. Therefore, PCWA's Revised Draft HPMP (May 2011) includes measures to manage this site with respect to potential impacts associated with the operation and maintenance of the MFP, including potential impacts associated with inundation, wave action, and fluctuating water levels. Section 4.3 of the Revised Draft HPMP identifies these potential impacts and includes the following specific measures that address the UAIC's concerns: (1) cultural resource site condition monitoring and consultation; and (2) additional surveys. These measures are described further in the following subsections.

Cultural Resource Site Condition Monitoring and Consultation

As specified in Section 6.5 of the Revised Draft HPMP, PCWA will revisit the site once every five years to monitor the condition of the site over time. The site visit will be conducted by archaeologists who meet the Secretary of the Interior's Standards and Guidelines in archaeology. Native American Tribes also will be invited to participate in site monitoring activities. During the site visit the archaeologist will survey each site for previously recorded artifacts and features, and will document the condition of the site, noting any changes. No ground-disturbing activities will be conducted and no artifacts will be collected. Survey observations will be documented on standardized Department of Parks and Recreation (DPR) cultural resources inventory forms (523 forms).

If adverse impacts are identified through these monitoring efforts, PCWA will consult with the United States Department of Agriculture-Forest Service (USDA-FS), SHPO, and the Native American Tribes, as appropriate, to identify and design measures that address the specific nature of the effect. Any new measures proposed to reduce project effects will be filed with the FERC for approval. These measures will be implemented by PCWA upon approval by FERC.

Additional Surveys

As specified in Section 6.7 of the Revised Draft HPMP, PCWA will conduct an additional survey of the lands inundated by the Project reservoir in coordination with the USDA-FS once over the term of the next license. This survey will be conducted during the late summer or early fall when water levels recede to an elevation that were not previously surveyed. The purpose of this survey is to determine whether additional cultural resources are present in areas of the reservoir that are usually submerged. The survey will provide data related to the prehistoric and historic use of the area around the Project reservoir, and may provide additional insight regarding site FS-05-03-55-682.

In addition, in the unlikely event that the Project reservoir is drawn down below the minimum pool elevation requirement, PCWA will survey the areas of the bottom of the reservoir that have not been previously surveyed for cultural resources. This survey effort would be designed and conducted in consultation with the USDA-FS and representatives of the Native American Tribes.

UAIC COMMENT NO. 2

The UAIC furthermore contends that the water draw-downs through FERC actions and through the management plan for the reservoir and downstream ecology should require further consultation.

PCWA RESPONSE NO. 2

PCWA believes that further consultation is not required regarding management of Project reservoirs (i.e., drawdown of Project reservoir) or environmental resources in stream and river reaches downstream of Project facilities. PCWA has conducted

extensive consultation and detailed analysis of the effects of proposed license conditions on water level fluctuations in Project reservoirs and resulting effects on biological and cultural resources. Similarly, PCWA has conducted extensive consultation and detailed analysis of the effects of proposed license conditions on environmental resources in stream and river reaches downstream of Project facilities. A comprehensive summary of the MFP relicensing consultation history with resource agencies, Native American Tribes, and other stakeholders is provided in PCWA's Final License Application – Section 14.0. In addition, the potential effects of fluctuating WSE in Project reservoirs on biological and cultural resources and potential effects of proposed license conditions on downstream ecological resources has been thoroughly evaluated in PCWA's Final License Application – Section 8.0.

CONCLUSION

The UAIC has been a valuable partner in the development of the Historic Properties Management Plan for PCWA's FERC relicensing process. PCWA appreciates this opportunity to respond to the UAIC's comments concerning the MFP and looks forward to continuing to work with you on the MFP relicensing as well as other watershed and local issues.
