Thank you for reviewing and commenting on the Draft LAND 1 Technical Study Report- 2008.

We received your comment:

"The initial study plan listed four roads associated with potential betterments (Table Land 1-2). Appendix "G" contains information on only one of those roads with no mention of the status of the other three."

Table LAND 1-2 of the report lists all four potential Project Betterment Roads, including three roads that do not currently exist, but would be constructed as part of the Betterment projects themselves. Appendix G contains a survey of the one Betterment road that currently exists, as this road may require modification in order to accommodate the French Meadows Powerhouse Capacity Upgrade Betterment. A survey of this road was conducted to establish baseline conditions.
